### Welcome to HETRA: Program Overview and The Therapy Team

# Speakers' Bios:

**Katherine Smith** completed her BS degree in Occupational Therapy from the University of Kansas. After working in hospitals, nursing homes and private therapy clinics, she found the perfect job combining therapy and her love of horses. HETRA, or Heartland Equine Therapeutic Riding Academy became a passion for Katherine on the first day back in 1995. Having just purchased her first horse a year prior, she became involved with HETRA as a side walker and quickly joined Edye Godden, OTR/L in treating children with disabilities using horses. Edye is now the CEO and Katherine is the Program Manager for this non-profit organization. HETRA now provides services to all ages and people of all abilities. Katherine has completed the American Hippotherapy Association Level I and II courses, has maintained certification as a therapeutic riding instructor for many years, and received ESMHL certification several years ago. Katherine spends most of her time in the barn with the Therapy Services participants utilizing Hippotherapy.

**Diane Bemis** joined the HETRA team in 2006. She became a PATH, Intl. certified instructor in 2012. She has a Bachelor of Science in Occupational Therapy. Diane has also completed the American Hippotherapy Level 1 and Level 2 Courses.

# Diagnostic Classification and Management Strategies for Patients with Low Back Pain

### Presentation Overview:

This course is designed to share an evidence based approach to the physical therapy examination, diagnosis, and management of patients with low back pain by comparing and contrasting some of the more common systems used by physical therapists. The course will provide an overview of various systems as well as the diagnostic labels used and the appropriate treatment strategies. A lab component of this course will be aimed at giving the learners a chance to try many of the commonly used exercises from each of the systems.

### **Objectives:**

- The learner will be able to describe various strategies for the physical therapy examination, diagnosis, and management of patients with low back pain
- The learner will be able to identify and perform appropriate components of the examination of patients with low back pain
- The learner will be able to create a treatment or management strategy for patients with low back pain that is in accordance with the patient's presentation and matched to the patient's diagnosis

#### Speaker's Bio:

**Zane Ochs** is a physical therapist in Wichita, Kansas with 7+ years of experience serving a variety of patient populations including outpatient orthopedics, acute care, home health, and sports and functional fitness athletes. Zane received a BA in Exercise Science from Wichita State University in 2010 and his DPT from Washington University in St. Louis in 2013. Zane achieved Orthopedic Clinical Specialist status from the APTA in 2015 and Fellowship status from the American Academy of Orthopedic Manual Physical Therapists in 2018. He was a poster presenter at CSM in 2018 for a case study regarding the management of costochondral pain. Zane received the Outstanding Clinical Service award from the KPTA in 2019 and served as a volunteer physical therapy provider for the Wichita State University alumni team, The Aftershocks, in The Basketball Tournament in 2019. Zane has served in a variety of roles with the DPT program at Wichita State University including as a clinical educator, adjunct faculty member, and a member of the academic advisory committee.

# Animal Physical Therapy In The 21st Century: Historical Perspectives, Educational Standards, Clinical Practice, and Legal Implications

### **Presentation Overview:**

The practice of treating animals by licensed physical therapists has grown exponentially nationwide since the 1970s. Many of the skills used by physical therapists to treat animals are transferable with additional educational competencies in anatomy, biomechanics, pathology, and relevant behavioral adaptations and restraint. Identifying educational opportunities to acquire such competencies however has been limited due to a lack of post-graduate courses, especially those taught by licensed physical therapists. In addition, no formal documented standards of education for animal practice have existed until recently, and multiple scope of PT practice laws exhibit unfortunate barriers to the profession.

Part I of this session will address the practice of animal physical therapy, a brief history, evolution, and current state of the art. Part II will highlight research conducted on behalf of the Animal Physical Therapy Special Interest Group of the Academy of Orthopedic Physical Therapy, APTA. Details of a completed practice analysis, including an outline of essential competencies in clinical practice for animal physical therapy in the United States, will be presented. Part III will address concerns expressed by the veterinary profession and state policy and regulatory agencies regarding jurisdictional definitions of veterinary medicine, physical therapy, direct access, and term and title protection. Strategies to address underlying factors impacting regulatory issues and concerns by veterinarians regarding this niche market in PT clinical practice will be highlighted.

Objectives:

- Provide an historical perspective on the treatment of animals by physical therapists with a focus on current state laws and regulations related to clinical practice
- Present the purpose, methodology, analysis, and implications of data used to codify competencies defining the current educational standards of practice for animal physical therapy
- Outline common perspectives from the veterinary profession both in support of and opposition to physical therapists treating animals and highlight examples of successfully negotiated language presently codified in several state jurisdictions
- Discuss relevant issues and concerns related to facilitating successful communications between the professions of Physical Therapy and Veterinary Medicine

### Speaker's Bio:

**Dr. Peck** holds a Bachelor of Science degree in Exercise Science, a Master's degree in Physical Therapy, and a PhD in Higher Education, Administration, and Leadership. He is current Chair of the Department of Physical therapy at Creighton University, Omaha, NE with a teaching focus in political advocacy, and clinical exercise physiology and wellness. Dr. Peck provides outpatient orthopaedic physical therapy pro bono services to the Native American population residing in Omaha, and is certified in both canine and equine rehabilitation with a focus on treating canine injuries, and equine in service for therapeutic riding and Hippotherapy.

Dr. Peck served two-terms as President of the Nebraska Physical Therapy Association, including 20-years as Chair of the state legislative committee. In addition, he served two-terms as President of the Animal Rehabilitation Special Interest Group (ARSIG) of the Orthopedic Academy, American Physical Therapy Association. He is current Vice Chair of the Nebraska Physical Therapy Licensure Board and was recently selected to serve on the Federation of State Boards of Physical Therapy as Chair of the Ethics and Legislation Committee. Dr. Peck has consulted with numerous physical therapists nationwide addressing political issues related to animal rehabilitation, and presented nationally at the APTA State Government Affairs Forum, APTA Combined Sections, and the Federation of State Boards of Physical Therapy. Finally, Dr. Peck worked extensively with the Nebraska Board of Veterinary Medicine and Surgery to draft statutes and regulations allowing PTs to acquire a professional license to treat animals following completion of additional educational competencies.

# **Vestibular Rehabilitation: Current Concepts and Future Directions**

### Presentation Overview:

This presentation will cover the anatomy, physiology and pathologies that affect the vestibular system. Symptom presentation will be used to make a differential diagnosis so that optimal outcome measures can be used to detect change with interventions. The pathology and interventions to treat a common vestibular condition, Benign Paroxysmal Positional Vertigo, will be discussed. Evaluation and treatment of vestibular hypofunction following the Clinical Practice Guidelines will be outlined. With the COVID-19 pandemic, the role of telehealth and the barriers to effectively treat patients with vestibular hypofunction will be highlighted by Dr. Sarah Gallagher. Additionally, more recent vestibular diagnoses, Persistent Postural Perceptual Dizziness (3PD) and Vestibular Migraine, will be discussed by Dr. Lisa Farrell.

### **Objectives:**

- · Describe the pathophysiology and symptom presentation of common vestibular conditions
- Use appropriate outcome measures and interventions for the management of BPPV and vestibular hypofunction
- · Adapt in-clinic assessments and treatment to perform an effective telehealth session
- Identify 3PD and Vestibular Migraine using the diagnostic criteria and describe medical management and physical rehabilitation intervention in patients with these diagnoses

### Speaker's Bio:

**Dr. Linda D'Silva, PT PhD, NCS**, is an Assistant Professor at the University of Kansas Medical Center. She is the Director of the STABILII laboratory which is focused on the diagnosis and management of persons with vestibular disorders. She has investigated the impact of Type 2 diabetes on the vestibular system, and she is currently examining the relationship between visual-vestibular deficits and mobility in adults with a mild traumatic brain injury. She is an active member of the Vestibular Special Interest Group of the American Physical Therapy Association.

**Dr. Sarah Gallagher PT, DPT, NCS** is the owner of South Valley Physical Therapy which specializes in neurologic and vestibular rehabilitation. Dr. Gallagher identified that access to expert vestibular rehab is limited due to limited expertise in the state of Colorado, long travel distances, and dizziness impeding commuting to the clinic. This problem led her to implemented telerehab at South Valley PT for insurance reimbursement in 2017. She has presented on implementing telerehab at several national and state PT conferences.

**Dr. Lisa Farrell, PT, PhD, ATC** has been providing vestibular and balance rehabilitation for adults with various neurological pathologies in the South Florida area since 1999. She has been a guest lecturer and adjunct faculty member of Nova Southeastern University with neuroscience being her area of teaching since 2003. Since 2000, she has been a faculty member for the APTA's Vestibular Rehabilitation: A Competency-Based Course, and in 2013, became a co-director of this program. Additionally, she has been part of the faculty for the APTA's Pediatric Vestibular Rehabilitation: A Competency-Based Course from its inception in 2010 until 2018. With her graduate degrees, she concentrated her area of study in the field of balance as well as in vestibular assessment and rehabilitation. In 2017, Dr. Farrell founded Symmetry Alliance, LLC, a consulting firm for program development and provider of continuing education for rehabilitation professionals, so that she can contribute to helping communities improve their medical care for patients with vestibular pathology. Throughout her career, she has served her profession by being an active member of the American Physical Therapy Association.
